## **Deposit Policy and Appointment Preparation**

Thank you for choosing **Hotrod Tattoo Incorporated**, we are committed to providing you with the best possible experience. By continuing with the process and leaving the required deposit indicates that you understand and agree to the following guidelines.

- 1. Deposits are NON-REFUNDABLE, Please be completely sure of your decision.
- 2. We understand that schedules change, so in the event you need to reschedule- HRT requires 48hours advanced notice and at that point we would be happy to find you a new appointment day and time. If you are starting to get sick, please call and reschedule, instead of waiting till the day of your appointment in hopes that you would feel better. We are reserving and holding your appointment time special for you, and we can not transfer your deposit if this policy is not adhered to...
- If you are pregnant or nursing it is our professional advise to not get a Tattoo or Body Piercing.
- 4. We understand that your tattoo is important to you, and a great deal of thought is put into deciding what you will put on your body. If you change your tattoo design or ideas for your tattoo we need to have time to prepare so we require at least 48 hours notice for any changes. Minor changes can be made the day of your appointment.
- 5. Your tattoo will take approximately 4-6 weeks to heal. At that point if your tattoo needs a touch up, please take advantage and schedule a complimentary touch up appointment. This should be completed 1-2 months after it has completely healed.
- 6. HRT is here to build lasting relationships through amazing artwork, and professional service. We do our best to complete your tattoo in the time frame quoted, but please be aware that an additional appointment might be necessary and there may be an additional fee. The more time and money you invest the more amazing your tattoo will be.
- 7. In order to make this a positive experience, we recommend that you get a good nights rest, eat a healthy meal and drink plenty of water prior to your appointment. Getting tattooed exerts a great deal of energy and stress and should be taken seriously. We will not be able to proceed with your tattoo if you are intoxicated or under the influence of drugs.
- 8. HRT is committed to being the leader in the body modification industry. To comply with OSHA guidelines, we can not allow food or beverages in the lobby or work areas. You are allowed to bring water or we can provide you if necessary.
- Our work areas have limited space, so we ask that you only bring 2 guests to observe your tattoo.
- 10. At this point we encourage you to ask any questions that may be important to understanding the permanency of what you are scheduling for. We are more than happy to schedule you a consult with your artist prior to your appointment, so please let us know.

I acknowledge by signing this agreement that I have been given the full opportunity to ask any and all questions which I might have about the obtaining of a tattoo and that all of my questions have been answered to my full satisfaction. I specifically acknowledge I have been advised of the facts and matters set forth below and I agree as follows:

- If I have diabetes, epilepsy, hepatitis, hemophilia, HIV-AIDS, or any other communicable disease, heart
  condition or take medicine which thins the blood I have advised my tattooist. I am not pregnant or nursing. I
  am not under the influence of alcohol or drugs.
- I do not have medical or skin conditions such as but not limited to: acne, scarring (Keloid), Eczema, psoriasis, freckles, moles or sunburn in the area to be tattooed that may interfere with said tattoo. If I have any type of infection or rash anywhere on my body, I will advise my tattooist.
- I.acknowledge it is not reasonably possible for the representatives and employees of this tattoo shop to
  determine whether I might have an allergic reaction to the pigments or processes used in my tattoo, and I
  agree to accept the risk that such a reaction is possible.
- I acknowledge that infection is always possible as a result of the obtaining of a tattoo, particularly in the
  event that I do not take proper care of my tattoo. I have received aftercare instructions and I agree to follow
  them while my tattoo is healing. I agree that any touch-up work needed, due to my own negligence, will be
  done at my own expense.
- I realize that variations in color and design may exist between any tattoo as selected by me and as ultimately
  applied to my body. I understand that if my skin color is dark, the colors will not appear as bright as they do
  on light skin.
- I understand that if I have any skin treatments, laser hair removal, plastic surgery or other skin altering
  procedures, it may result in adverse changes to my tattoo.
- I acknowledge that a tattoo is a permanent change to my appearance and that no representations have been
  made to me as to the ability to later change or remove my tattoo. To my knowledge, I do not have a physical,
  mental or medical impairment or disability which might affect my well being as a direct or indirect result of
  my decision to have a tattoo.
- I acknowledge I am over the age of eighteen and that I have truthfully represented to my tattooist that the
  obtaining of a tattoo is by my choice alone. I consent to the application of the tattoo and to any actions or
  conduct of the representatives and employees of the tattoo shop reasonably necessary to perform the tattoo
  procedure.
